

**OMSI JOURNEY TO SPACE GIVEAWAY
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED BY LAW. ONLY OPEN TO LEGAL RESIDENTS OF OREGON AND WASHINGTON. In order to enter the OMSI Journey to Space Giveaway (the “*Sweepstakes*”) and receive the prize, you will not be required to purchase goods or services, pay any money, or submit to a sales promotion effort.

The Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Instagram. You are providing your information to OMSI and not to Instagram. By participating in the Sweepstakes, you agree to a complete release of Instagram from any claims.

The Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook. You are providing your information to OMSI and not to Facebook. By participating in the Sweepstakes, you agree to a complete release of Facebook from any claims.

1. SWEEPSTAKES ENTRY PERIOD. The Sweepstakes begins on Friday, June 17, 2016, at 5:00 AM Pacific Daylight Time, and ends on Wednesday, August 31, 2016, at 11:59 PM Pacific Daylight Time (the “*Entry Period*”). The Sweepstakes is a game of chance, and the winners will be chosen in random drawings in accordance with Section 5 below.

2. HOW TO ENTER.

(a) **NO PURCHASE NECESSARY. YOU MUST READ AND ACCEPT THESE OFFICIAL RULES BEFORE YOU ENTER THE SWEEPSTAKES. BY PARTICIPATING IN THE SWEEPSTAKES, YOU ACKNOWLEDGE AND AGREE TO ACCEPT AND ABIDE BY THESE OFFICIAL RULES. FAILURE TO COMPLY WITH THESE OFFICIAL RULES WILL VOID YOUR ENTRY. ANY ENTRY THAT IS INCOMPLETE, ILLEGIBLE, INACCURATE, FORGED, IRREGULAR IN ANY WAY, OR IS OTHERWISE NOT IN COMPLIANCE WITH THESE OFFICIAL RULES WILL BE DISQUALIFIED.**

(b) There are two ways to enter the Sweepstakes. You must choose one method only.

i. **SUBMIT A PHOTO.** During the Entry Period, visit the Journey to Space Exhibition (the “*Exhibition*”) at Oregon Museum of Science and Industry (“*OMSI*”), located at 1945 SW Water Avenue, Portland, Oregon 97214, during OMSI operating hours (posted at www.omsiedu), and take a photo of yourself (a “*Submission Photo*”) in any of the following three Exhibition locations, one of which is located in the OMSI lobby prior to ticketed entry and each of which is marked with signage indicating it as a Sweepstakes photo location:

- Gemini Capsule photo location, located in the OMSI patron lobby, prior to ticketed entry;
- Space Toilet photo location, located on the first floor of the Exhibition in OMSI; or
- Mars Landscape photo location, located on the second floor of the Exhibition in OMSI.

Post the photo to your Instagram account, to your Facebook account, or to a comment thread associated with the Sweepstakes on OMSI’s Facebook page, and tag the photo with @OMSI and the hashtags #MissionOMSI and #entry. The Submission Photo must be posted during the Entry Period. By using the hashtag in connection with your Instagram and/or Facebook post, you acknowledge and agree that OMSI

has the right to stream your post through the Instagram and/or Facebook application program interface (API) or otherwise use your post as set forth in these Official Rules. To enter the Sweepstakes by posting your Submission Photo to Instagram, your Instagram account must be public. To enter the Sweepstakes by posting your Submission Photo to Facebook, you must change the privacy settings for the Submission Photo to public. If, due to the privacy settings on your Instagram or Facebook account, OMSI is not able to see or search for your Submission Photo post, your Submission Photo will not be entered in the Sweepstakes.

ii. **ALTERNATIVE METHOD OF ENTRY.** If you do not enter the Sweepstakes by uploading a Submission Photo to Facebook or Instagram during the Entry Period in accordance with these Official Rules, you can enter by mail during the Entry Period by legibly printing your name, complete address, home phone number, email address, and date of birth on a standard-sized postcard and mail your entry to OMSI, 1945 SW Water Avenue, Portland, Oregon 97214, Attn: Journey to Space Giveaway (the “**Alternative Method of Entry**”). If your Alternative Method of Entry is selected as a winner in the Sweepstakes, then you will be contacted by email and by telephone; please be sure to provide a valid email address and telephone number for this purpose. Alternative Method of Entries considered for a Weekly Prize (as defined in Section 5 below) must be postmarked on or before the last day each Sweepstakes Week (as defined in Section 5 below), and must be received by OMSI before the Wednesday immediately following the last day of each Sweepstakes Week. Alternative Method of Entries considered for the Second Place Prize and Grand Prize (as those terms are defined in Section 5 below) must be postmarked on or before August 31, 2016, and must be received by OMSI before 5:00 PM PDT on September 7, 2016.

(c) **Number of Times You Can Enter the Sweepstakes.** You may enter the Sweepstakes up to a total of forty (40) times during the Entry Period by *either* (i) posting a maximum of forty (40) Submission Photos to Instagram or Facebook, *or* (ii) mailing a maximum of forty (40) Alternative Method of Entries. For the avoidance of doubt, one Submission Photo that is posted to both your Instagram and your Facebook accounts will count as two entries, *however*, additional postings of the same Submission Photo on the same social media account (i.e., posting one Submission Photo five times to Instagram) will not be entered into the Sweepstakes and will not increase your chances of winning.

(d) **You Must Submit Your Entry During the Entry Period.** TO BE CONSIDERED FOR THE SECOND PLACE PRIZE AND THE GRAND PRIZE, ALL ENTRIES MUST BE POSTED TO INSTAGRAM OR FACEBOOK BY 11:59 PM PDT ON AUGUST 31, 2016, OR, IF MAILED, POSTMARKED BY AUGUST 31, 2016, TO BE ELIGIBLE. ENTRIES SUBMITTED OR POSTMARKED BEFORE OR AFTER THE ENTRY PERIOD WILL BE AUTOMATICALLY DISQUALIFIED.

(e) Entries are subject to verification and may be disqualified if they are late, misdirected, incomplete, illegible, irregular, submitted through illicit means, or do not conform to or satisfy any condition of these Official Rules. No mechanically reproduced, illegible, or incomplete entries will be accepted. The use of any device to automate the entry process is prohibited. OMSI reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes.

3. ELIGIBILITY RESTRICTIONS.

(a) Only legal residents of Oregon and Washington are eligible to enter the Sweepstakes. You must be at least 13 years of age to enter the Sweepstakes. If you win the Second Place Prize or the Grand Prize (as defined in Section 5, below), both you and your guest(s) must be at least 18 years of age or, if under the age of 18, be accompanied by your respective parent(s) or legal guardian(s).

(b) Persons affiliated with or employed by OMSI are ineligible to enter or win. Members of the immediate families and/or households of such persons may not participate or win. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations.

(c) Winners of the Sweepstakes (and a parent or legal guardian, if the winner is under 18 years old) may be required to sign certain releases and forms (described in more detail below) in order to claim their prize.

4. USE OF YOUR SUBMISSIONS AND PERSONAL INFORMATION.

(a) All Submission Photos and Alternative Method of Entries shall become the property of OMSI and will not be acknowledged or returned. By submitting an entry:

(i) You represent and warrant that your entry and all elements contained therein (the “Content”) is original to you and does not contain any material that would violate or infringe upon the rights of any third party, including copyrights (including, without limitation, copyrighted images or footage), trademarks, and rights of privacy or publicity. You further warrant and represent that you have all appropriate clearances, permissions, and releases for your entry, including releases from all persons appearing in your Submission Photo(s) and releases from anyone who assisted in the creation of your Submission Photo(s). You must be able to provide on request all appropriate clearances, permissions, and releases. If you cannot provide all required releases, OMSI reserves the right, in OMSI’s sole discretion, to disqualify the applicable entry or seek to secure the releases and clearances for OMSI’s benefit.

(ii) For each Submission Photo, you (on behalf of yourself and those appearing in your photo) hereby grant OMSI a nonexclusive, universal, compensation-free right and license (with full rights to sublicense through multiple tiers) to (i) copy, distribute, perform, display, modify and to create derivative works of the photo submitted; and/or (ii) use the names, addresses (city and state, only), biographical information, and testimonials of anyone appearing in your Submission Photo(s), for advertising, marketing, promotion and/or publicity purposes, in all forms of media now known or later devised, for a period of three (3) years after the Entry Period ends. OMSI may require that you and/or those who appear in your Submission Photo(s) sign a photographic license and/or publicity release form to evidence these grants of rights and licenses. You shall have no right of approval, no claim to compensation, and no claim (including, without limitation, claims based on invasion of privacy, defamation, rights of integrity or attribution, or right of publicity) arising out of any use, blurring, alteration, or use in composite form of your name, image, picture, likeness, voice, address (city and state), email address, biographical information, or entry. The rights granted under this paragraph shall extend to OMSI for all entrants in the Sweepstakes, including entrants who are selected as prize winners and those entrants who are not selected. OMSI shall have no obligation to use the winning entries or any other entry for any purpose.

(b) Your entry shall not: (1) contain trademarks or copyrighted material (other than OMSI) not owned by you or used without permission (including, but not limited to, company names and other brand names); (2) use individuals’ names, in whole or in part, without permission; (3) refer to public figures; (4) contain profanity, pornographic or sexual content, content promoting alcohol, illegal drugs, tobacco, firearms, or weapons, hateful content of any kind (including racism, sexism, etc.), content that promotes violence or harm to another living creature, or any other offensive, obscene, or inappropriate content; (5) defame, misrepresent, or contain disparaging remarks about other people or companies, including, but not limited to OMSI; (6) promote a political agenda regardless of the political affiliation; or (7) contain materials embodying the names or other identifying elements of any person, living or dead, without permission.

5. PRIZES.

(a) By entering the Sweepstakes, you could win the following prizes:

Weekly Prizes:

- Winner's choice of (i) four (4) OMSI Attraction Passes (Approximate Retail Value: \$34), or (ii) one (1) OMSI Family Membership (Approximate Retail Value: \$105) (each, a "**Weekly Prize**"). Further details about each of these Weekly Prizes can be found at www.oms.edu.
- One (1) winner will be randomly chosen from the entries received for each Sweepstakes week (a "**Sweepstakes Week**") as described in more detail below. Sweepstakes Weeks are as follows:

- Submission Photos considered for a drawing for a Sweepstakes Week must be posted between 12:00 AM PDT at the start of such Sweepstakes Week and 11:59 PM PDT at end of such Sweepstakes Week.
- Alternative Method of Entries considered for a drawing for a Sweepstakes Week must be postmarked between the start of such Sweepstakes Week and the end of such Sweepstakes Week, and must be received by OMSI no later than the Wednesday immediately following the end of such Sweepstakes Week.
- The odds of winning a Weekly Prize depend on the number of eligible entries received for such Sweepstakes Week. Your odds of winning a Weekly Prize will decrease as the number of eligible entries in a Sweepstakes Week increase.
- On each Thursday following a Sweepstakes Week (and, on or about Thursday, September 8, 2016 for Week 11's Weekly Prize), one (1) Weekly Prize winner will be selected by a random drawing from all qualified entries received within the timelines stated herein for such Sweepstakes Week. OMSI will conduct the Weekly Prize drawings, and such drawings shall be final. Weekly Prize winners will be notified on the drawing date in the manner in which the winning entry was received (i.e., via Instagram, Facebook, or by telephone and email address if an Alternative Method of Entry was selected as the winner). If OMSI is unable to connect with a Weekly Prize winner after two (2) business days of drawing such

winner, an alternate winner will be selected by a random drawing from the remaining qualified entries.

- In order to be awarded and to receive a Weekly Prize, the winner may be required to execute and return an Affidavit of Eligibility and Publicity/Liability Release upon accepting a prize. Noncompliance will result in disqualification, and an alternate winner may be selected.
- If you win a Weekly Prize, you are still eligible to win the Second Place Prize or the Grand Prize (but not another Weekly Prize) with your remaining Sweepstakes entries.

Second Place Prize:

- One (1) second place prize winner will win an indoor skydiving adventure with iFly Portland (located at 10645 SW Greenburg Road, Tigard, Oregon 97223) for the winner and up to four (4) of the winner's guests (Approximate Retail Value: \$299.95) (the "**Second Place Prize**").
- The Second Place Prize winner will be selected by random drawing from all qualified entries received during the Entry Period (or, if an Alternative Method of Entry, postmarked on or before August 31, 2016, and received by OMSI before 5:00 PM PDT on September 7, 2016).
- The odds of winning the Second Place Prize depend on the number of eligible entries received. Your odds of winning the Second Place Prize will decrease as the number of eligible entries increase.
- The Second Place Prize winner will be selected on or about Friday, September 9, 2016. OMSI will conduct the Second Place Prize drawing, and such drawing shall be final. The Second Place Prize winner will be notified on the drawing date in the manner in which the winning entry was received (i.e., via Instagram, Facebook, or by telephone and email address if an Alternative Method of Entry was selected as the winner). If OMSI is unable to connect with the Second Place Prize winner after five (5) business days of drawing such winner, an alternate winner will be selected by a random drawing from the remaining qualified entries.
- In order to be awarded and to receive the Second Place Prize, the winner will be required to execute and return an Affidavit of Eligibility and Publicity/Liability Release prior to acceptance of the Second Place Prize. Noncompliance will result in disqualification, and an alternate winner may be selected. The Second Place Prize winner's guest(s) must also sign and return a Publicity/Liability Release prior to the Second Place Prize winner accepting the Second Place Prize.
- If you win the Second Place Prize, you are not eligible to win the Grand Prize.

Grand Prize:

- One (1) grand prize winner will win a trip for two to visit Space Center Houston with a Level 9 behind-the-scenes VIP tour of NASA's mission control. Space Center Houston is located at 1601 NASA Road 1, Houston, Texas 77058. The grand prize consists of: two (2) roundtrip coach air transportation tickets from either Portland International Airport (PDX) or Seattle-Tacoma International Airport (SEA), whichever is closest to the grand prize winner's residence, to Houston George Bush Intercontinental Airport (IAH); two (2) nights' hotel accommodations, standard double occupancy, at a hotel to be selected by OMSI or OMSI's travel agent, including either roundtrip airport transfers in Houston or a 3-day car rental from the airport in a rental car to be selected by OMSI or OMSI's travel agent; and two (2) tickets to Space Center Houston including a guided, Level 9 tour of NASA's mission control (collectively, the "**Grand Prize**"). Approximate Retail Value: \$2,500.
- The Grand Prize winner will be selected by random drawing from all qualified entries received during the Entry Period (or, if an Alternative Method of Entry, postmarked on or before August 31, 2016, and received by OMSI before 5:00 PM PDT on September 7, 2016).
- The odds of winning the Grand Prize depend on the number of eligible entries received. Your odds of winning the Grand Prize will decrease as the number of eligible entries increase.
- The Grand Prize winner will be selected on or about Friday, September 9, 2016. OMSI will conduct the Grand Prize drawing, and such drawing shall be final. The Grand Prize winner will be notified on the drawing date in the manner in which the winning entry was received (i.e., via Instagram, Facebook, or by telephone and email address if an Alternative Method of Entry was selected as the winner). If OMSI is unable to connect with the Grand Prize winner after five (5) business days of drawing such winner, an alternate winner will be selected by a random drawing from the remaining qualified entries.
- The Grand Prize winner must use the Grand Prize on or before May 1, 2017, subject to availability. Blackout dates, including restrictions on travel during certain holidays, may apply. The Grand Prize winner must give OMSI at least thirty (30) days' written notice of the winner's selected travel dates. OMSI will book, or will cause to be booked through its travel agent, the air transportation tickets, hotel accommodations, and rental car reservation (if applicable).
- The Grand Prize winner and the winner's guest must both be 18 years of age or older, or, if under the age of 18, must be accompanied by their respective parents or legal guardians (OMSI will not cover the travel expenses and costs of the parent or legal guardian if the parent or legal guardian is not considered the travel guest of the Grand Prize winner). The winner and the winner's guest (and their respective parents or legal guardians, if applicable) must travel on an identical travel itinerary. Any and all expenses incurred by the winner or the winner's guest to travel to the Originating Airport are solely the responsibility of the winner and

the winner's guest. The winner and the winner's travel guest must possess all necessary documentation required for air travel (e.g., valid photo identification). All other expenses not specifically mentioned herein (including but not limited to taxes, personal charges, meals, tips, gratuities, travel and trip insurance, and ground transportation) are solely the responsibility of the Grand Prize winner. The Grand Prize winner may be required to present a valid credit card upon check-in at the hotel to cover any incidental expenses. OMSI shall have no responsibility for canceled, delayed, suspended or rescheduled events or travel. No prize substitutions, cash equivalent, or transfer of prizes will be permitted except at the sole discretion of OMSI.

- In order to be awarded and to receive the Grand Prize, the winner will be required to execute and return an Affidavit of Eligibility and Publicity/Liability Release prior to acceptance of the Grand Prize. Noncompliance will result in disqualification, and an alternate winner may be selected. The Grand Prize winner's guest must also sign and return a Publicity/Liability Release at least thirty (30) days' prior to travel.
- The Grand Prize is expressly limited to the item(s) listed above and does not include taxes, gratuities or any other expenses. Other restrictions may apply.

(b) Prizes are nontransferable and may not be redeemed for another prize. By participating in the Sweepstakes and accepting a prize, participants and winners will be deemed to agree to these Official Rules. Travel is not included in the prize unless specifically stated. **ALL FEDERAL, STATE AND LOCAL TAXES ARE THE SOLE RESPONSIBILITY OF THE WINNER.** The winner may be required to sign an IRS Form W-9 or the equivalent. OMSI reserves the right to substitute a prize of equal or greater value at any time, in its sole discretion.

(c) As a condition to receiving a prize, a winner may be required to provide proof of eligibility, including driver's license or other valid photo identification and other proof of the winner's age and state of residence. If the identity of an entrant is disputed, the entrant will be deemed to be the account holder of the Instagram account, Facebook account, or email address provided at the time of entry. An entrant may be required to provide proof that the entrant is the authorized account holder of the Instagram account, Facebook account, or email address associated with the winning entry.

(d) All decisions by OMSI with respect to the Sweepstakes are final, and, by participating in the Sweepstakes, each entrant releases and discharges OMSI from any and all liability related to winner selection, disqualification, and selection of alternate winners.

6. IMPORTANT DISCLAIMERS AND LIMITATIONS.

(a) If, for reasons beyond OMSI's control, the Sweepstakes cannot be conducted as originally planned, including if any virus, bugs, unauthorized human intervention, fraud, or other causes corrupt or affect the administration, security, fairness, or proper conduct of the Sweepstakes, OMSI reserves the right to cancel or modify the Sweepstakes, without liability, in its sole discretion. If, due to circumstances beyond the control of OMSI, any prize-related product or event is delayed, rescheduled, postponed or cancelled, OMSI reserves the right, but not the obligation, to cancel or modify the Sweepstakes and shall not be required to award a substitute prize.

(b) OMSI reserves the right to make changes in the rules of the Sweepstakes, including the substitution of a prize of equivalent value, which will become effective upon announcement.

(c) OMSI is not responsible for typographical or other errors in the printing, the offering, or the administration of the Sweepstakes, these Official Rules, or in the announcement or notification of a prize.

(d) OMSI and its directors, officers, employees, agents, affiliates, contractors and representatives (the "***OMSI Parties***"), are not responsible for technical, hardware, software, telephone or other communications malfunctions, errors or failures of any kind, lost or unavailable network connections, website, Internet, or ISP availability, unauthorized human intervention, traffic congestion, incomplete or inaccurate capture of entry information (regardless of cause) or failed, incomplete, garbled, jumbled or delayed computer transmissions that may limit one's ability to enter the Sweepstakes, including any injury or damage to participant's or any other person's computer relating to or resulting from participating in the Sweepstakes.

(e) OMSI reserves the right, at its sole discretion, to disqualify any individual it finds, in its sole discretion, to be tampering with the entry process or the operation of the Sweepstakes. OMSI may prohibit an entrant from participating in the Sweepstakes or winning a prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other unfair playing practices (including the use of automated quick entry programs) or intending to annoy, abuse, threaten or harass any other entrants or OMSI representatives.

(f) ANY ATTEMPT BY AN ENTRANT TO DELIBERATELY DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES SHALL DISQUALIFY SUCH ENTRANT, AND OMSI RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH ENTRANT TO THE FULLEST EXTENT PERMITTED BY LAW.

(g) TO THE MAXIMUM EXTENT PERMITTED BY LAW, THE OMSI PARTIES HEREBY DISCLAIM ANY WARRANTIES, OBLIGATIONS, LIABILITIES, RIGHTS AND REMEDIES, EXPRESS OR IMPLIED, ORAL OR WRITTEN, ARISING BY LAW OR OTHERWISE, INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, TITLE, INFRINGEMENT OR ANY IMPLIED INDEMNITIES. YOU UNDERSTAND AND ACKNOWLEDGE THAT OMSI HAS NOT MADE, AND YOU ARE NOT RELYING ON, ANY EXPRESS OR IMPLIED WARRANTIES OR REPRESENTATIONS TO YOU REGARDING THE VALUE OF THIS SWEEPSTAKES OR THE ODDS, WHETHER YOU WILL BECOME A WINNER, OR ABOUT THE SUITABILITY, RELIABILITY, AVAILABILITY, TIMELINESS, LACK OF VIRUSES OR OTHER HARMFUL COMPONENTS AND ACCURACY OF THE INFORMATION, PRODUCTS, SERVICES AND RELATED GRAPHICS USED IN CONNECTION WITH THE SWEEPSTAKES OR THESE OFFICIAL RULES. THE PRIZES AND ALL DATA, INFORMATION, PRODUCTS, SERVICES AND GRAPHICS RELATED TO THE SWEEPSTAKES AND THESE OFFICIAL RULES ARE PROVIDED "AS-IS, WHERE-IS" WITHOUT TECHNICAL SUPPORT OF ANY KIND. 7. YOUR RELEASE OF OMSI FROM ANY AND ALL LIABILITY.
